#### David R. Patterson, 32° KCCH Wise Master, Chapter of Rose Croix

David Patterson was born in Glendale, California. Following high school he enrolled at the University of Colorado but, during his sophomore year, his Naval Reserve Unit was activated for service in Korea.
