

### Meet the Wise Master



## Daniel G. Harvey, Jr., 32° Wise Master, Chapter of Rose Croix

Worshipful Brother Daniel "Skip" Harvey was born at Chicago, Illinois in 1944. He departed Chicago to attend the University of Wisconsin, Madison on an NROTC Scholarship in 1962. Prior to graduation from Wisconsin he asked his Grandfather to become a Mason. In less than a month he was Initiated, Passed and Raised in Cornerstone Lodge #875, Chicago, Illinois all in the month of August, 1966. Being raised in Cornerstone Lodge was important for several reasons. First, it was the same Lodge his grandfather, Frank Harvey, was raised in and was Master of in the early 1920's. Secondly, his raising was the last lodge function that his grandfather would attend; he joined the celestial lodge above two weeks after Skip became a Master Mason.

After graduation from Wisconsin with a Bachelor of Arts degree in Political Science in 1967 he was commissioned an Ensign, USN and entered flight training at Naval Air Station, Pensacola, Florida. He earned his Naval Aviator wings in 1968 and was posted to NAS, Beeville, Texas as an advanced jet tactics instructor and then to NAS, Lemoore, California as a fleet attack pilot where he transitioned to the A-7 Corsair II attack aircraft. He joined Attack Squadron ONE FIVE THREE and flew 300 missions in South East Asia from the USS Oriskany.

Upon returning to the states in 1973 he was posted to Test and Evaluation Squadron FIVE, Naval Weapons Center, China Lake. Where he served as a Test Pilot and Operational Test Director for light attack aircraft performance Continued on page 8

April and Spring bring forth the Ceremony of Remembrance and Renewal. Every Brother should make the effort to attend the April 1st meeting in which we celebrate the lives of

those who have passed and renew our own selves to the ideal of the human spirit and the tenants of Freemasonry. This is a family event so your family is invited to take part in breaking the bread of Fraternal kinship.

May is approaching rapidly and the May reunion is looming but the applications are sparse. Have you talked about Scottish Rite Masonry to a brother you feel is deserving to take on our teaching and ceremonies? Are you willing to mentor a brother or two in the teachings of our fraternity. And 40 brothers passed on. That is a loss of 137 members. Over all we had a decrease in membership of 69 for 2015. It

### The P.R.'s Corner

Ill. Rees Padfield, 33°

Ugh! April is here. Death and taxes, they say. Tax's are due. I wish everyone could owe nothing which means you had just the right withholding. The Pasadena Scottish Rite is doing everything it can to reduce its expenses to assist in the maintaining the health of the Rite, including the Language Center and the building itself. We are continuing to replace incandescence and fluorescence light fixtures with LEDs. We are in the process of replacing our two stage lighting systems with LEDs.

Our new air conditioner is more energy efficient. We are replacing our phone provider which will result in reduction of about one half of the monthly cost. By using digital means to distribute the Bulletin, we have cut costs from over \$2000 a month to less than \$700 a month. While we strive to reduce operational costs, other expenses continue to grow impacting both the Cathedral Board and the Lodge of Perfection. The per capita owed to the Supreme Council continues to grow and now \$23.00 per member. There is also a current Orient per capita of \$3.00. Of course, utility costs only increase. We will continue to be alert to where we can be more efficient.

The new restrictions of how much we can use of our Children's Language Foundation investment account staring in July 2017 will be debilitatingly serious unless we support our Rite's charitable events and strive to increase our support. We will need to obtain nearly \$80,000 in donations, bequeaths and gifts. I urge all of you to talk to your Lodges to see if they will also support our Language Center. I also ask if your employer will match your most generous gifts to the Language Center. All working together we can keep our Center here at Pasadena Scottish Rite.
