# Charles C. Krefting, 32° KCCH Master of Kadosh Consistory

There are many things that make Freemasonry enjoyable. Near the top of my list is Masonic readings. Near the bottom of the list is writing. I know! You can't have the first without the second, but I find writing extraordinarily difficult. What makes it more difficult right now, is that I am writing this on a cruise ship crossing the Atlantic. I knew I would have plenty of distractions, so I brought a couple of my favorite readings to keep me on track - the Scottish Rite Journal (current issue) and A Bridge to Light.



An article in SRJ started with a sentence: "Seemingly casual conversations sometimes have significant consequences." The article went on to give the fascinating account of a casual conversation that evolved into a plan, then a script, and finally the production of a documentary on the history and form of the Masonic Table. But before I could get into the very well written and intriguing article, my mind went off on a tangent on how true that first sentence was.

I immediately thought of a casual conversation I had with my step-father years ago. I was seriously thinking about joining Masonry and had done a fair amount of reading about the subject. The veteran Mason asked me what the greatest thing I expected to get out of Freemasonry. I believe I answered with some variant of the old saw 'to make a good man better'. In less than a blink of an eye he countered, "Naaaaa! It's Fellowship!" You are going to make friends and quality of friendships that will be hard to match."

His prophesy came true. The friendships I have made are at the very top of the enjoyable things in Masonry. And through association, by hanging around better men, by following common tenets and virtues, by repeating lesson-invoking rituals founded in ethics, justice and humanity, we all become better men. Whether concerted effort was made or unconscious, the good of my brothers rubbed off. And from our casual conversation, I petitioned my lodge in North Carolina for membership.

has crossed more borders than I had experienced. While I was in the military, engineering, construction and management fields, my associations were for the most part, people in my (or Carol's) line of work. But when I became a Mason, I became exposed to new friends of all occupations and all types of backgrounds. The statement of making close relations "with those of whom you would otherwise remain at a perpetual distance", becomes obvious.

Though my brothers and I are very different, we are not so different in our beliefs. Not religious or political beliefs, but what we believe is right or wrong in our actions and our obligations to each other. Our backgrounds and personal life's lessons developed our way of thinking. I recognize my brothers' experiences and lessons are different and obviously developed different viewpoints. I respect that and their opinions, as they should mine. If we want we can debate our political or religious differences of opinions (out of the lodge room), and at the same time respect each other. Changing his mind is far less important than his friendship. Isn't a good debate more rewarding than a festering grudge?

Learning to agree to disagree reminds me of the lesson taught in the Provost and Judge Degree. In today's world too often differing opinions are taken as personal affronts, and lead to unwarranted judgments of others. In Provost and Judge, the degree teaches you not to be too anxious to judge. A judge takes on a responsibility and a burden. To be a judge a person must be fair, impartial, divorced from personal biases or influenced by personal acquaintances, be well informed, and above all be willing to stand under the same judgement. Remember, in time, you too may be judged, and possibly on how you have judged others.

It is my wish that the politicians and people in media would be less judgmental, take their biases out of their work and be more civil. In other words, be more Masonic.

What I was looking for as a prospect I have found, and has proven an old Mason's words in a casual conversation to be true. I have made many and varied friends that I respect and am proud to call, "My Brother". I have much in common with my brothers and much that is unique.

I am humbled by the trust you have placed in me as Master of Kadosh; the responsibilities of which I hope I can fulfill with honor.

He originally hailed from the Pacific Northwest. He was born in Tacoma, Washington. He spent his early years in Western Washington, later moving to California, Colorado, Arizona and then back to Washington.

He attended the University of Washington majoring in Political Science, then switched to Forest Engineering. He received his B.S. Degree in Forestry in 1972 along with his commission as a 2nd Lieutenant in the Army Corps of Engineers. While at the U of W he met the love of his life, his wife of 53 years, Carol.

He was in the Army from 1972 until 1978 with stateside assignments in heavy equipment and underwater construction. The last year and one half he was attached to the Navy as Liaison Officer and instructor at the Naval School, Diving and Salvage, Washington, D.C.. He left the Army as a Captain.

Staying in the Washington D.C. area, he traveled to the North Sea and Mexico supervising diving operations in the offshore oilfields. Following this, and for the next decade, he worked in various fields including underwater construction and engineering, mechanical and marine engineering, and shipboard design and prototype work. This was followed by twenty years in commercial building construction management and supervision.

He was initiated in Monroe Lodge No. 244 A.F. & A.M. in Monroe, N.C. Two weeks later he was driving across the country to Simi Valley to catch up with Carol, whose work brought her out to California. He was passed and Continued on next page

raised as courtesy degrees at Simi Valley Lodge No. 806. Upon being raised he affiliated as dual member into Simi Valley Lodge. Going through the line, he served as Master of Simi Valley Lodge in 2013. Upon completion of his year in the East, he became editor of Simi Valley's Trestleboard and chairman of the Funeral Committee, which he continues to do to this day. He joined the valley of Pasadena Scottish Rite in the spring of 2014, in the Class of Hon. Richard Lundine. He immediately began his service in support of the Dining Room, and eventually followed Illustrious Elmer Boomhower as the Dining Room manager. In the summer of 2018 he joined the Knights of St. Andrew. And in 2019 he received double honors of the Hiram Award and his Red Cap. He is also a member of Al Malaikah Shrine, Conejo Valley High 12 Club #634 and is on the Advisory Board of Fidelity Assembly, International Order of Rainbow for Girls.

In 2017, he and Carol went on Grand Master John Heisner's 300th Anniversary of Freemasons Trip to the UK. His visits to the Grand Lodges of Ireland, Scotland and England's Freemason Hall, as well as stops at Rosslyn Chapel and the William Wallace Monument rekindled his love of history.



# Statement of Principles

Issued by: Ancient Accepted Scottish Rite, Southern Jurisdiction; Ancient Accepted Scottish Rite, Northern Masonic Jurisdiction; Shriners International

The Southern Jurisdiction and Northern Masonic Jurisdiction of the Ancient and Accepted Scottish Rite of Freemasonry, along with Shriners International, were founded as appendant bodies of symbolic Masonic Lodges. These Lodges are chartered and governed by their applicable Grand Lodge. Each of our members are and must remain, members in good standing in a Lodge existing within a recognized Grand Lodge. Our organizations believe that Masonic principles as identified through Grand Lodges are foundational, not merely optional, principles upon which we build to provide further light.

As appendant bodies of the Grand Lodge system, our organizations operate in a manner consistent with the basic principles of Freemasonry. Inherent in these principles is that our members should be seen as good men, continually striving to improve themselves, their character, and their actions, so that we can collectively extend a positive and benevolent influence on the world at large.

We believe the Masonic principles that guide our members' lives have been proven, over centuries, to improve their character and perspectives. As Masons or Masonic organizations, our failure to meet the exceptionally high standards of conduct expected of us is almost always the result of our failure to understand or apply the Masonic principles we have been taught. When we fail to meet the standards of conduct required of Masons, our response is to correct and remedy that failure, not to lower our standards.

We recognize that all humans are fallible and at times, the actions of a member may fall below the high expectations of our Fraternity. We further recognize that, in those cases, Lodges, Grand Lodges, and our own organizations may, of necessity, be required to investigate, and, within established practices, take appropriate disciplinary actions against individual Brothers. We support these actions, in the longstanding belief that such efforts will result in an improvement both within the individual and within our Fraternity at large.

Our interest in adhering to Masonic principles relates not only to improving our members but also specifically to continuing to enjoy an outstanding reputation for integrity and service within our communities.



#### Birth of the Scottish Rite: Charleston, May 31, 1801.

On May 24, 1801, John Mitchell created the Reverend Frederick Dalcho (a Prussian, born in London) a Deputy Inspector General of the Order of the Royal Secret, and one week later, on May 31, "the Supreme Council of the 33d Degree for the United States of America, was opened ... agreeably to the Grand Constitutions" in Charleston, South Carolina, with Col. Mitchell and Rev. Dalcho presiding. The Supreme Council was a superior system to Morin's Order of the Royal Secret; it administered thirty-three degrees, including all twenty-five of Morin's rite.

The traditional authority of the Supreme Council stems from the "Grand Constitution of the 33d degree" (also Grand Constitutions 0/1786), ostensibly ratified by Frederick II ("the Great"), King of Prussia." The earliest known copy dates from about 1801-02, and is written in Rev. Dalcho's hand. (...) The Circular throughout two Hemispheres, or "1802 Manifesto" (the first printed document issued by the Supreme Council), also asserted that Frederick the Great instigated its creation

#### Library Treasures, continued...

On the 1St of May, 5786 [1786], the Grand Constitution of the 33d degree, called the Supreme Council of Sovereign Grand Inspectors General, was finally ratified by his Majesty the King of Prussia, who as Grand Commander of the order of Prince of the Royal Secret, possessed the Sovereign Masonic power over all the Craft. (...)

The Most Puissant Grand Sovereign-Grand Master Commander in Chief-Sovereign of Sovereigns of the degree of Prince of the Royal Secret, was our Illustrious brother, Frederick the 2:nd King of Prussia. He established this degree, in concert with our brother, his Serene Highness, Louis of Bourbon, Prince of the Blood Royal of France, and other Illustrious characters, who had received the degrees of K.H. and prince of the Royal Secret ....

This new Degree he called "Sovereign Grand Inspectors General, or Supreme Council of the 33:rd" (...)

The "Supreme Council at Charleston," as it was sometimes called, was the first Supreme Council of the 33rd Degree in world. It continues to exist today as the Supreme Council, 33°, Southern Jurisdiction, and its see remains in Charleston, although its residence was moved to Washington, D.C., about 1870, and it now sits at the House of the Temple. (...) As we shall see later on, a little more than a decade later the Supreme Council at Charleston would create a second Supreme Council in the United States. (...)

In 1804 Alexandre-Auguste de Grasse-Tilly, a member of the Supreme Council at Charleston, organized a Supreme Council for France. In an agreement made that year between this newly created Supreme Council and the Grand Orient of France (which operated as a Grand Lodge), the title "Ancient and Accepted Scottish Rite" (Rite Ecossais Ancient et Accepté) was used for the first time.

Beginning with the administration of Grand Commander Albert Pike in 1859, the name came into general use in the Southern Jurisdiction.

The Northern Masonic Jurisdiction- Ratified May 21, 1815; Unified May 15, 1867.



... on August 5, (...) "The Supreme Council of the Thirty-third Degree for the Northern Masonic District and Jurisdiction" was organized, with New York Governor (and later Vice President) Daniel D. Tompkins as Grand Commander.

On May 21, 1814, this Supreme Council reopened ... forming the second Grand and Supreme Council..." --- the Ratification ought to be dated 21st day May 5815."

The reason for the creation of the Supreme Council, 33°, Northern Masonic Jurisdiction (NMJ), was to combat a bogus "Supreme Council" previously created by Joseph Cerneau, (...) In a long and interesting history the regular Scottish Rite Masons in New York continued to battle against Cerneauism, with occasional defections on both sides, until the two bodies reconciled on May 15, 1867, in what is now known as the "Union of 1867." This resulted in the formation of the current Supreme Council, 330, NMJ.
