Meet the Master of Kadosh

Military:

Michael was born in Wyoming, but his family moved to Northern California when he was three years old. He grew up in Northern California, in Silicon Valley, and learned a great deal about computers, which at the time was uncommon. His parents both worked in High Tech firms. After his high school graduation, he enlisted in the United States Air Force, was granted a Secret Clearance, and became a Firefighter. He likes to claim that he is both a military veteran and a veteran first responder. He was fortunate enough, while in the Air Force, to be stationed in Germany and temporarily in England and Greece. He took full advantage of living in Europe and traveled to every non-communist country in Western Europe, which at the time was over twenty countries; he even visited East Berlin, which required special military protocol. Through this experience, he learned the importance of history, architecture, and most importantly a sensitivity to other cultures.

University:

After returning from Europe and completing his military commitment, earning an honorable discharge, and being awarded the good conduct medal, Michael attended San Jose State University. He studied accounting but was yearning for the comradery that he had enjoyed in the military, so he joined Social and Honorary Fraternities on campus, This led to him being elected Inter-Fraternity President, Student Body Controller (Treasurer) and Student Body President. As Student Body President of a University with over 30,000 students and a multi-million-dollar budget, Michael had similar responsibilities as a Mayor of a small town. He sat on all the major boards including Academic Senate which set student curriculum, Athletic Board, which hired coaches and set policy, Book Store, which was a full retail operation, Student Union Board of Directors, which was a multi-storied building that included a bowling alley, a commercial ticket outlet, a ball room, food services, and housed various offices and employees. He had regular weekly meetings with the University President, was interviewed by newspapers, radio, and television, and was hired part-time as one of only two Executive Assistants to San Jose City Council Woman Lu Ryden. He made presentations at the California State University Board Continued on next page...

of Trustees in Long Beach and received a letter of appreciation from the Chancellor. Michael was on the statewide board of CSU Student Body Presidents and traveled to Washington D.C. where he met as a part of a group with several politicians that had an impact on our education. Finally, since it was a Presidential election year, was chosen to sit on the stage, along with US Senator Pete Wilson, California Governor George Deukmejian, and other local politicians, for President Reagan's only Northern California appearance for his reelection campaign. The event was attended by thousands of people and televised nationally.

Professional:

After graduation, Michael was offered political opportunities, but choose instead to join the largest accounting firm in the world, at the time – Arthur Andersen - as an auditor. Later, he was recruited to work for PWC (named Price Waterhouse at the time) on their Computer Assisted Tax Service Team (CATS) and then to EY (Ernst & Young) as Senior Tax Consultant. After relocating to Los Angeles, Michael's career evolved more into professional recruiting. He started with Robert Half International, which was at the time the largest recruiting firm specializing in the recruitment of accounting professionals. Later, Michael founded his own C-Corporation and had several employees and also founded a computer consulting company. Over his decades of work in consulting, in accounting, and in recruiting he has worked for several large and notable companies.

A Tribute to Our Mothers

May is a month filled with holidays and days of special interest. There is May Day, Memorial Day, Armed Forces Day, Cinco de Mayo, National Teacher Appreciation Day, even World Tuna Day. But the most personal day of all is Mother's Day. On that special day, we take time to honor our mothers for all the love and sacrifice they unselfishly give each day. And no matter how old we become; we are still our mother's children.



It was the suggestion of Anna Jarvis who proposed that a day be set aside to honor and cherish our beloved mothers. Having lost her own mother in 1905, she set off on a journey to make that day a reality. And, in 1914 by decree of President Woodrow Wilson, that day became ever cemented in the hearts of all Americans.

It is interesting to note that Ms. Jarvis chose the carnation to represent this special day. Red carnations denoted a mother who was still living. A white carnation for a mother who has passed on. This idea did not escape Brother Frank S. Land, the founder of the Order of DeMolay. The first of the Seven Cardinal Virtues is Filial Love. One of the ceremonies a young DeMolay receives is known as the Flower Talk. It is a tribute to motherhood and the undisputed love of a mother for her children. At the end of the ceremony, the member is instructed to take a carnation from the altar. Red for his living mother, which he presents to her on this occasion as a sign of love and respect. White if his mother has passed, which he keeps as a remembrance of her. If you remember weathercaster Wilard Scott, you may have noticed he always wore a white carnation on his suit coat lapel. This was not a coincidence. Brother Scott was a DeMolay and had received the Flower Talk ceremony as a young member. He never forgot the lessons of that ceremony and was so touched by it that he continued to wear a white carnation every day of his life as a tribute to his mother. An example worthy of imitation.

So, on that second Sunday in May, take the time to reflect what your mother meant to you and how she guided you to become the man, the mason, you are today.



TWENTY-NINTH DEGREE.

Grand Scottish Knight of Saint Andrew.

HISTORY

When the Order of The Knighthood of the Temple of Solomon, or of The Knights of the Temple, the Poor Fellow-Soldiers of Jesus Christ, which was established in 1118, had been declared heretical by Pope Clement V., at the instance of Philip the Fair of France, in 1307; when all of the Order in France had been arrested and imprisoned, many executed, more tortured, and all impoverished;

when, in most of the other European States, the Estates of the Order had been confiscated and divided between the Sovereign, the Knights Hospitalers, and the Pope; and when the Grand Master and the Grand Preceptor Guy had been burned alive, on the 18th of March, 1313, Old Style; the Templars no longer had a common head, nor could anywhere maintain their organization under their old name, which had become so famous.

Their possessions confiscated, their leaders incarcerated for life or put to death, the Brethren persecuted in every way, the survivors were compelled, for the sake of concealment, and to be in safety, to leave their homes, lay aside the garb of the Temple, and mingle again with the world, or enter other Orders. In Portugal, where they were pronounced innocent, the name of the Order was changed to that of the Order of CHRIST. In England King Edward proscribed them, and forbade them to remain in the realm, unless they entered the Commanderies of the Knights of St. John of Jerusalem, or of the Hospital. In Scotland they found protection, and joined the army with which King Robert Bruce met the invasion of his country by Edward II. of England.

The battle of Bannockburn was fought on the 24th of June, 1314. In consequence of the assistance rendered him on that memorable day by the Templars, Bruce created, and received them into, the Order of Saint Andrew du Chardon [of the Thistle], of Scotland. This was afterward annexed to the Degrees of the Rite of Heredom, Herodom, or Hierodom, a word coined from the two Greek words [Hieros domos], HOLY HOUSE, and said to be the name of a mountain in Scotland (where there is no such mountain), to conceal the real name of the Order, which' was "THE HOLY HOUSE of the TEMPLE at Jerusalem." The meaning hidden in the word "HOLY" you may, perhaps, be hereafter fortunate enough to learn.

King Robert reserved to himself and to his successors forever the title of Grand Master of the new Order;. And granted a charter of lands to Walter de Clifton, Grand Preceptor of the Templars for Scotland, for the assistance which they rendered him at Bannockburn.

Prince Charles Edward Stuart was the last Grand Master of the Order of Herodom in Scotland, and exercised his powers in France, by establishing a Chapter of Rose Croix at Arras, and by other acts. And when the Ancient and Accepted Scottish Rite was finally organized, by those in possession of the Degrees of the Rites of Herodom and Perfection, and of other Rites and detached Degrees that had been from time to time established in Scotland, France, Germany, and elsewhere, the Order of Grand Scottish Knights of Saint Andrew became the 29th of the new Rite, formed by selecting, from the different Rites and Observances, seven Degrees, in addition to the twenty-five of Perfection; and creating the 33d, as the Supreme and last Degree, to rule the whole.
