

The month of May is an important one to Scottish Rite Freemasonry, for it was on May 1, 1786, that the Grand Constitutions of 1786 were alleged to have been adopted, which provided for a Rite consisting of Thirty-three degrees under the title of the Ancient and Accepted Scottish Rite and governed by a Supreme Council. This constitution shaped the structure of the Scottish Rite Freemasonry practiced in the United States today. A Supreme



Council was then opened in Charleston, South Carolina on May 31, 1801, which established the "Mother Council of the World."

Given our rich history of traditions and with our degree conferrals soon approaching, I would like to remind each one of our membership to invite at least one non-Scottish Rite Mason to come out and receive the Masonic Light that the Pasadena Scottish Rite Valley has to offer. I believe all that our brothers need is an introduction to Scottish Rite Freemasonry and they will realize the value added by attending our meetings. We already have a sizeable class, but it would increase the experience if the auditorium was filled not only with class members but also with members who help guide them to assist in our great work, in whatever manner suits them.

That being said, we are now in the spring season and we have begun the transition from the cool to warm months of the year. We are all now being showered with the great waves of the glorious light from nature, we should never forget that we are also being given the gift of internal light and it is our indispensable duty to share that light in all our doings. 
