

Remember your oath to service, my brothers!



Treasurer's Report

Miles H. Bresee III, 32° KCCH

Greetings Brethren...

Some of you may have noticed, and others perhaps not...the bank statement balances with identification of remittances over \$1,000 is no longer part of the monthly Bulletin. The omission was made with the belief that no one looks at the information. However, in keeping with our Valley's desire for transparency, as a replacement I offered to provide a quarterly summary of our finances and



investments. As our PR has stated, and it is my position as well...if anyone has specific questions about our finances or investments...to simply ask. If someone wants to see something specific, our books and records are available for review during business hours upon request. Similarly, if anyone wants something included in this quarterly report, please let me know!

The 3rd Quarter is behind us with the close of September 30th. Allow me to provide some information for our two main areas, notably,...the Lodge of Perfection and Cathedral Association separately below.

Lodge of Perfection: Q3 Budget vs Actuals: Revenue: 75% Expenses: 66% The LOP is probably the more straightforward of the two to budget. We have fixed and variable expenses, such as salaries and payroll taxes, insurance, utility, office related and dining expenses. Variable expenses include those programs the Venerable Master desires to include during his year. Other variable expenses are the 'every other year' Honors or Workshops, and Reunion related programs.

Cathedral Association: Q3 Budget vs Actuals: Revenue: 71% Expenses: 82%

The Cathedral Association (and if you'll allow me to abbreviate as 'Cath Assn'...) would normally be fairly easy to budget. However, the past several years we've been in a multi-year program to rehabilitate various areas of Continued on next page

our beautiful building...Women's Association Lounge, bathrooms, interior painting, new carpeting, installation of the 'Madison Window' in the Grand Staircase area, wiring and lighting, identification of some 17 leaks and fixing them, replacement of air conditioners, etc. This year our expenses (again as of September 30th) have been new Degree costumes, elevator repairs, and refurbishing our paintings. The primary source of our revenue comes from a lease agreement for the Ironworker's Union parking lot to the east of our property. When available, additional revenue flows to the Cath Assn from the Event Center, which is responsible for renting out our dining room, building for movie shoots, and other purposes.

Expanding on Cath Assn expenses at the beginning of the year, we budgeted \$200K for the Dining Room project. At the time the budget was prepared and approved, the Cathedral Board was still in the process of defining what the dining room scope of work should be...lighting, sound, floors, acoustic paneling, electrical, etc. The 'fixed goal' for the Dining Room was to have the work completed and be available for our 100 Year Anniversary in February 2025. Once several Contractors were found to provide proposals, the one selected based on his quality of work, had a total base contract for the dining room and electrical of approximately \$367K. As of September 30th, we have paid the dining room Contractor \$151K against his contract. In an ideal world, we would have funded the work with cashflow from parking lot and other rental bookings. However, in the real world...the dining room has been unavailable to us for rentals since the Spring, as we did not know when we would find a Contractor and/or start the work. This also made this year's planning on the Lodge of Perfection side by our Venerable Master, Robert Artinian very challenging. We have been fortunate that our Contractor has progressed with the planned work at a faster pace than anticipated. And looking at 'the number's, one can see that contractually at the end of September we owe \$216K against the base contract. We'll get to our investment accounts in a moment, but yes...we have taken funds from our investment account(s) to pay for some of this work. For those of you in attendance at least 3 Stated Meetings in the past, Vram Martirosyan outlined the overarching objective of the work on our building. That is...'to have all of the repairs, deferred maintenance and improvements completed, with the

Dining Room to be the showcase for generating rental income and returning those funds to the Cathedral Association'.

Investments

On October 9th, the Finance Committee met via Zoom with our Investment Manager, Bob McClure to review our accounts, market conditions, and discussion of potential changes to our portfolios. Generally, the economy is doing moderately well...employment is considered to be full (traditionally defined as less than 5%), inflation is down and close to the Fed's target of 2%, the service sector has seen a bit of inflated prices, and sales have decreased in some areas. A concern is that if the Fed reduces interest rates further, it may result in triggering higher inflation. Turning to our overall investment portfolio (combining our 5 investment accounts, as each has its own allocation) ... for the 3rd Quarter the return was 6.68% vs the benchmark, 3 months 6.68% vs 5.22% benchmark, Year to Date 9.49% vs 14.81 benchmark, Inception to Date 7.16% vs 8.88% benchmark. The benchmark is 60% Equities/30% Fixed Income / 10% Cash. Individual investment accounts have done better than what the blended investment accounts portray. Our current (blended) portfolio is approximately 68% US Stock/29%Bonds/3% Cash. Our target portfolio is 60% US Stock/40% Bonds and Cash or equivalents. With potential election year, Fed policy (interest rate and other), the Ukraine and Middle East conflicts, it was decided not to make any changes to our portfolio. As a note...our investments are all in mutual funds and our adopted Investment Policy Statement is closely aligned with that outlined by the California Masonic Code. We do not own individual stocks, derivatives, hedges, commodities, etc. ... just mutual funds.

It is hoped that this initial quarterly summary of our finances provides some insight into them. Again, transparency is our (and MY) goal! The Librarian's Memo Pad

The Regius Manuscript, also known as the "Regius Poem," is a pivotal document in the history of Freemasonry. Here's an overview of its context and historical significance:

Context

1. Origin: The manuscript is believed to have been written around 1390, in England. It is named after the British Museum's King George IV, who acquired it in the 19th century. The document is written in rhymed



couplets, reflecting the poetic tradition of the time.

- 2. Content: The Regius Manuscript outlines the duties and responsibilities of stonemasons and provides a moral framework for their conduct. It includes teachings on loyalty, charity, and the importance of the craft. It also discusses the historical origins of the craft and offers a kind of mythical genealogy.
- 3. Masonic Traditions: The manuscript serves as one of the earliest examples of what would later become the "Old Charges," a set of rules that would guide the practices of operative and speculative Freemasonry.

Historical Context

- 1. Medieval Guilds: The manuscript reflects the guild system of medieval England, where tradespeople organized themselves into groups to protect their interests and regulate their work. Stonemasons, in particular, held significant status due to the construction of cathedrals and other monumental buildings during this period.
- 2. Transition to Speculative Masonry: The late 16th and early 17th centuries saw a shift from operative masonry (actual stonework) to speculative masonry (philosophical and moral teachings). The Regius Manuscript captures some of the transitional elements of this evolution.
- Cultural Influence: The themes in the manuscript mirror broader

societal values of the time, including the importance of community, ethical conduct, and the search for knowledge. As Europe was moving toward the Renaissance, these values were critical in shaping the emerging philosophical landscape.

4. Impact on Freemasonry: The Regius Manuscript laid the groundwork for the formalization of Masonic rituals and practices that would develop in the following centuries, particularly with the establishment of the Grand Lodge of England in 1717.

The Regius Manuscript remains a key resource for understanding the origins and evolution of Freemasonry, illustrating how the craft has adapted over centuries while retaining its core ethical principles. If you're interested in specific excerpts or themes within the manuscript, come use our library and research the foundations of Freemasonry.
