Greetings, Brethren and friends,

Throughout my Masonic journey, I have always been interested in learning how our fraternity reflects and incorporates the ethics and spiritual paradigms by which Western society has been shaped. In each of the degrees of the Blue Lodge, our ceremony revisits ideas from the ancient past, reminding us of their wisdom and applicability to the modern condition. Albert Pike was himself so enamored of these lessons that his most famous



book, Morals & Dogma encompasses tens-of-thousands of lines of text exploring what he believed to be the origin and significance of every bit of symbolism found in the thirty-two degrees of the Scottish Rite system.

Truly, contemplating our symbolism and the aims of Freemasonry, one can often find illuminating connections to ancient ideas from Greece, Judea, Arthurian Legend, and Eastern thought. While researching colors often used in Masonic rites (such as blue, gold, red, silver, black, and white), I found an interesting parallel between ancient Greek and Masonic symbolism of the colors black and white, which likely sheds light on our system of balloting.

As early as the 5th c. C.E., (around the same time 300 spartan soldiers held a last stand against Xerxes and his army of 300,000 at Thermopylae), the Athenians were casting votes using small black and white pebbles, where for example, white was used for "yea" and black for "nay," or, in the case of a court trial, the accused were acquitted by white pebbles, and condemned by black (Bible Study Tools, n.d.). The stones were then counted to render verdict. The Greek word for these stones was psephos, from which the scientific study of elections, psephology, is named. Even the modern word, ballot, preserves this

ancient history of bean-counting, as it comes from medieval French ballotte, meaning a small ball (Getty News, 2023). The Greek-language equivalent of the practice of Hebrew gematria (counting the value of the letters in a Hebrew word), is isopsephy meaning "equal count" and works the same way, i.e. by observing the numerical value of a Greek word and pondering the connection between those with the same numerical value.

The discovery of the possible inspiration for our use of black and white "pebbles" in lodge balloting, inspires me to dig further into our symbols and traditions to uncover further parallels. I hope it will do the same for you.

In conclusion, if the AASR really is the "university" of Freemasonry, then this kind of inquiry is our homework! I always enjoy discussing these topics and look forward to sharing more in my bulletin messages this year.

The Christian Kabbalah

Christian Kabbalah is an interpretation of Kabbalah within a Christian framework. Emerging in the Renaissance, it is a mystical tradition that sought to integrate Jewish mystical ideas, particularly those found in Kabbalistic teachings, with Christian theology. Christian Kabbalists saw Kabbalah not merely as a Jewish discipline but as a universal, ancient wisdom that could enhance the understanding of Christian doctrines.



Here's an overview of its key elements, history, and influence:

1. Historical Background

Christian Kabbalah began in the 15th and 16th centuries, largely through the work of Christian scholars who encountered Jewish mystical texts. The Italian philosopher Giovanni Pico della Mirandola was one of the earliest figures to introduce Kabbalah to the Christian world. He believed Kabbalistic teachings contained hidden truths that could support Christian doctrine, particularly ideas about the Trinity, the nature of Christ, and the process of salvation.

2. Key Concepts

• God's Emanations and the Sephirot: In Kabbalah, God manifests through ten emanations called the Sephirot, forming a "Tree of Life." Christian Kabbalists sought to map Christian symbols onto the Sephirot, often linking aspects of the Trinity to these emanations.

• Names of God and Divine Language: Christian Kabbalists

explored the sacred names of God and considered Hebrew to be a divine language. They believed that understanding these names allowed a closer connection to the divine, and even helped in understanding Christ's nature.

• Messianic Focus: Christian Kabbalah often centered around Messianic interpretations. For example, Kabbalistic concepts like the "Adam Kadmon" (primordial man) were interpreted to be metaphors for Christ.

• The Christological Reading: Figures like Johannes Reuchlin sought to integrate the Kabbalistic concept of "Tikkun" (restoration) into the Christian idea of redemption, positing that Christ's life and work were essential for the spiritual repair of the world.

3. Major Figures

• Giovanni Pico della Mirandola: A pioneer in merging Kabbalah with Christianity, Pico saw Kabbalah as a pathway to greater spiritual truths compatible with Christian teachings.

• Johannes Reuchlin: A German humanist who defended Jewish texts, Reuchlin believed Kabbalah held profound truths applicable to Christianity. His book De Arte Cabalistica (1517) was one of the first systematic works on Christian Kabbalah.

• Heinrich Cornelius Agrippa: A Renaissance thinker who integrated Kabbalistic and alchemical principles into Christian mysticism, Agrippa's works included Kabbalistic ideas on angelic hierarchies and the mystical significance of Hebrew letters.

• Athanasius Kircher: A Jesuit scholar whose works on symbology and mysticism popularized Kabbalistic ideas within Christian circles in the 17th century.

4. Influence on Western Thought

Christian Kabbalah greatly influenced the development of Western esotericism, including Rosicrucianism, Freemasonry, and Hermeticism. Renaissance humanism, which sought the reconciliation of religious knowledge with classical learning, was deeply impacted by Christian Kabbalah, which offered a way to integrate mysticism with Christian faith.


5. Legacy and Modern Perspectives

While Christian Kabbalah is no longer a major theological movement, its influence persists in various mystical and esoteric traditions. The works of Christian Kabbalists introduced concepts that would become central to Western mysticism and the occult. In modern times, some scholars view Christian Kabbalah as an example of religious syncretism and as an early attempt at interfaith dialogue, bridging Jewish and Christian spiritual traditions.

Christian Kabbalah remains a unique and complex branch of mystical thought, offering a lens to explore the intersection of Christian mysticism and Jewish esoteric wisdom.

A study of both the Jewish Kabbalah and the Christian Kabbalh is possible using our Pasadena Scottish Rite Library.

CHAPTER IV.

ADVENT OF FREEMASONRY INTO CALIFORNIA. THE GRAND LODGES OF MISSOURI, DISTRICT OF COLUM-BIA, AND CONNECTICUT THE FIRST MOTHERS OF CALI-FORNIAN FREEMASONRY.

A SHORT time after the close of the Revolutionary War for American Independence, the light of Freemasonry, like that just before the dawn, began to tip the crests of the Alleghany and the Appalachian range of mountains, then the western boundary of civilization, and soon thereafter to dart its rays of rising sunlight down the western slopes and across the lakes, the fountains of the St. Lawrence River, and the broad valley of the Mississippi, "the Father of Waters," and its tributaries. The Masonic and patriotic spirit and memories of the Masonic fathers of American Independence accompanied the great lights wherever the altars of Freemasonry were set up in the then vast wilderness filled with hostile tribes of Indians. The first Lodge

to be opened for work was at the town of Lexington, Kentucky, chartered by the Grand Lodge of Virginia, November 17, 1788, as Lexington Lodge, No. 25, F. & A. M., the town and Lodge having been named after Lexington in Massachusetts, where the first blood was shed in the American Revolution. The next in order was American Union Lodge, the charter having been granted to it by the Grand Lodge of Massachusetts, February 15, 1776, as a Military Lodge in the Connecticut Line of the American Army during the Revolutionary War, which found lodgment at Marietta, Ohio. It was opened by the Master, Lieut. JONATHAN HEART, with Col. BENJAMIN TUPPER and Gen. RUFUS PUTNAM as Wardens. There were several Brethren who had been members of the Military Lodge, No. 10, also warranted by the St. John's Grand Lodge of Massachusetts, and in all there were ten of these officers and soldiers of the Revolutionary Army who met and elected their officers, and opened this Lodge June 28, 1790.

The Grand Lodge of South Carolina chartered Parfait Union Lodge at New Orleans, Louisiana, March 30, 1794, to French refugee Brethren from the Island of Hayti, while the Grand Lodge of North Carolina granted a charter to St. Tammany Lodge, No. 29, at Nashville, Tenn., December 17, 1796.
