As I reported to you in meetings past, I have instigated actions leading to a financial audit of the Lodge of Perfection. This action will be conducted by a known and respected accountant and masonic auditor. I expect this business to be carried out in July. It goes without saying that the inspection of our books is not being pursued with negative intentions. It is more of a clarification exercise, in order to bring transparency to our financial records after such a vigorous expenditure of money we have experienced over the past five years. In fact, I believe such forensic audits should be standard practice in our Valley every two years.

Over the past few years, I have been performing the duties of the PSR Almoner, an honor indeed but a challenge nonetheless. The finances on my end is straight forward, however it's the determination of what constitutes a fair charitable donation is the issue. Considering the amount the recipients home lodge is willing or able to donate before I act and does the person in need qualify for other masonic outreach services? Until recently, I have been held to a specific amount of denotable funds I can expend. But in light of the disasters that have befallen our masonic families in Altadena and the Palisades areas and of course an economy unique to the 21st century, we've found the relief funds I offer often fall short, even with the assistance of other masonic bodies. As of now, I am increasing the amount of money the Almoner is allowed to donate. There are still conditions and limits, (as there should be) however I am now able to donate a larger amount of financial relief than what we have before. Let me be clear, I hope you don't need my services. But if unfortunate circumstances put you or someone you know in a bind, we will be happy to assist.

Over the past years I have prided myself on ritual prowess. However, I missed something important along the way. Such as what the words in the little blue book truly mean. The word Charity in particular appears, and I was shallow enough to think of it not as a concept to be made real but only something to memorize. After many missed opportunities I'm finally on the path of true charitable thinking and acting.

One of the first lessons we learn in Freemasonry is TIME, PATIENCE and PERSEVERANCE will accomplish all things. TIME is a unit of measurement that we all must deal with; you cannot control it. PA-TIENCE is the capacity to accept or tolerate delay, trouble, or suffering without getting angry or upset. And PERSEVERANCE is the continued effort to achieve a goal, even in the face of difficulty, failure or opposition.



I certainly learned this lesson dealing with our Supreme Council while trying to ascertain why we were not granted our 2024 Valley Membership Achievement Award or VMAP for short. We had satisfied all the requirements by meeting the goals we set at the beginning of the year and were told by the VMAP administrator that we were well on track and no problems were seen. And yet, when the memo of achievement Valleys was published, we were not among those listed.

Upon inquiry, we were told we did not submit our 4th quarter report (later revealed that a computer glitch was to blame) and that our final submission was late even though we had received permission from the VMAP administrator to submit late due to personal issues.

Upon hearing this, I immediately called the House of the Temple and spoke to the VMAP administration to plead our case asking them to review our submission and grant the award because, in my opinion, we did comply with all the requirements and had obtained, in advance, a short extension for submission. A little over a week after this conversation and several sleepless nights of working on my next argument and plea to the VMAP administrator, our office received a letter from the Sovereign Grand Commander, Illus-

trious James D. Cole, 33° announcing that the Valley of Pasadena had been recognized as a 2024 VMAP recipient. **T.P.&P.** had paid off.



Freemasonry and the two Saint Johns—John the Baptist and John the Evangelist—are deeply intertwined in Masonic tradition, both symbolically and historically. Their significance emerges in multiple layers: spiritual, ritualistic, and institutional.

1. Who Are the Saint Johns?

• John the Baptist: A fiery preacher known for baptizing Jesus. He represents moral rectitude, repentance, and spiritual preparation.

• John the Evangelist: Traditionally credited as the author of the Gospel of John, he symbolizes spiritual insight, light, and love.



2. Why Are They Important to Freemasonry?

a. Patron Saints of Freemasonry

Many Masonic lodges are dedicated to or named after the Saint Johns. These lodges are sometimes called "Lodges of St. John." In older traditions, they are regarded as the patron saints of Freemasonry, much like guilds or orders in medieval Europe would adopt saints for spiritual protection and moral guidance. b. Symbolism and Balance

The two Johns represent balance:

• John the Baptist: Stern, ascetic, focused on justice and repentance.

• John the Evangelist: Gentle, mystical, focused on love and illumination.

Together, they symbolize the duality at the heart of Freemasonry—action and contemplation, severity and mercy, law and grace.

3. Ritual and Calendar

- Masonic calendar: Two key feast days are often observed:
- o June 24 Feast of John the Baptist
- o December 27 Feast of John the Evangelist

These dates frame the solar year, aligning Masonic practice with natural cycles—a recurring theme in Masonic thought.

4. Historical Context

Some scholars argue that early Masonic lodges were aligned with St. John the Baptist as a carryover from operative stone mason guilds, which celebrated his feast as a holiday. Over time, especially with the rise of speculative Masonry in

the 17th–18th centuries, John the Evangelist was included to round out the symbolic meaning.

5. Esoteric Interpretation

In some esoteric interpretations, the Saint Johns represent the gateway pillars (like Boaz and Jachin in Solomon's Temple), flanking the Masonic path toward light and truth. They serve as guardians of the spiritual threshold, a concept tied to initiatory traditions.

Summary

The Saint Johns in Freemasonry are not merely historical or religious figures. They are archetypes used to express core Masonic ideals:

- Morality
- Balance
- Spiritual growth
- Continuity with sacred tradition

Their dual patronage reflects Freemasonry's emphasis on both ethical living and inner enlightenment.
