Upholding Patriotic Duty in Our Time Through Freemasonry and the Scottish Rite:

In a world marked by rapid technological change, social fragmentation, and political polarization, the concept of patriotic duty can often feel either outdated or misinterpreted. Yet, in these uncertain times, Freemasonry—particularly through the moral teachings and civic principles of the Scottish Rite—offers a profound, relevant, and stabilizing framework for renewing our commitment to the common good and national unity.



#### The Enduring Ideals of Freemasonry:

Freemasonry, one of the world's oldest fraternal organizations, has long emphasized a blend of personal virtue, civic responsibility, and universal brotherhood. Rooted in Enlightenment values, it calls on its members to be active, ethical participants in society. Patriotism, in Masonic terms, is not blind allegiance to government or ideology; it is a reasoned love for one's country, grounded in a commitment to justice, equality, and the rule of law.

This version of patriotic duty is more relevant than ever. As democracies around the world grapple with disinformation, distrust, and division, Masons are uniquely positioned to model the virtues of civil discourse, thoughtful leadership, and responsible citizenship.

Scottish Rite and the Elevation of Civic Duty:

The Scottish Rite, one of several appendant bodies in Freemasonry, deepens these teachings through a structured progression of degrees that explore philosophical, moral, and historical themes. Central to these degrees is the idea that knowledge and virtue are not ends in themselves—they must be translated into action for the betterment of society.

For example, in the 14° (Perfect Elu), the Rite emphasizes justice, integrity, and the moral responsibility to act on behalf of truth, even when it is inconvenient or unpopular. In the 18° (Knight Rose Croix), themes of renewal, sacrifice, and the triumph of light over darkness encourage members

to seek higher truths and serve humanity with compassion. These lessons delivered through allegory, symbolism, and ritual—reinforce the notion that patriotism is not mere sentiment, but the daily practice of Masonic values.

Patriotism Today: A Call to Masonic Action

In today's climate, the call to patriotic duty through Masonry may take many forms:

#### Civic Engagement:

Voting, volunteering, and community leadership are fundamental acts of patriotic service. Masons are encouraged to be informed citizens, not passive observers of democracy.

Promoting Unity Over Division: Freemasonry teaches that truth is found in dialogue, not dogma. Masons can help rebuild the social fabric by fostering respectful conversations across political and cultural divides.

Upholding Moral Standards:

In professions, communities, and public life, Masons are taught to act with integrity. Their example can help restore trust in institutions and encourage ethical conduct.

Mentoring the Next Generation: Through Masonic youth organizations and public education initiatives, Masons play a role in shaping the moral compass of future citizens.

#### Conclusion:

#### A Noble Task Ahead

In these current times—when the definition of patriotism is often contested— Freemasonry and the Scottish Rite provide a time-tested model for how to live honorably and serve faithfully. Masonic patriotism is not about flagwaving or slogans. It is about embodying the highest ideals of humanity in service to country, community, and conscience.

As Scottish Rite Masons continue their work in lodges, temples, and towns across the nation, they bear a sacred trust: to be builders not just of symbolic temples, but of a better, freer, and more just society. That is the true patriotic duty of our time.

# Greetings Brethren!

While this paper was written with the Blue Lodge in mind, the lessons contained are every bit as applicable to a Scottish Rite Valley, and I thought it would be worthwhile to share here.

"We Take Good Lodges and Make Them Better" (A Master's Manifesto)

Freemasonry is said to take good men and make them better. In this idea two things are implied:

- 1. That we must be good men, before and after we join
- 2. That even good men are not complete, and there is something more for them to learn, to gain, or to do.

By this theme we are taught that improvement is always possible, that growth is a journey, and that becoming better is our duty as long as we live.

This may seem obvious to us as masons. What may not be as obvious is the implication that a lodge, being made up of masons who are "good, and becoming better" has by extension the same duty, namely, to be good and actively working to be better.

Applying the process of self-improvement to the lodge as a body (or "egregore",

i.e. group mind from the Greek "grigori") involves active participation from each cell of the organism. We each have a role to play, and within our roles there are best practices that can support a healthy, effective, and joyous process of lodge growth.

The focus of this manifesto is to suggest ways in which members (at whatever stage they may be) can contribute to the improvement of the lodge as a whole. Beginning with Past Masters, considered the most "senior members," you are to support the lodge in any way possible because your knowledge and experience is an asset. Because you have been there and have had to learn some of the hardest lessons already, you can add valuable insight. You are also perceived to be the wisest members of the lodge, so you must strive to act it. Be patient, encouraging, and whisper good counsel but also be okay when your counsel is not heeded, for some need to learn by experience. You are especially tasked with supporting the Master, for you remember how hard that job can be. A Master has a grand hope and new energy that can transform a lodge for the better- or quickly dissipate in frustration- and your help and support make all the difference!

The Master's "design upon the trestleboard" defines the culture of the lodge. It sets the tone and defines what the rest of the lodge considers to be the standard; since whatever the master considers acceptable will become the standard, he must aim high and always strive for the best possible vision of his lodge, always working to define and maintain the highest standards. Yet, he must not be attached to the outcome; his duty is to steer and lead by example, remembering that success is a journey.

Wardens, you have the most important job in the lodge! You set the standard of brotherly love and affection that the lodge will emulate, and you cannot expect your members to follow the example of the master if you cannot yourself do so. For instance, you can merely "indulge" the master out of a sense of duty, or you can encourage him and lend support out of respect and brotherly love. The spirit with which you carry out your duties is everything.

The more cheerfully you step up to help and support the master, the more likely the rest of the membership will be to follow your example. When your turn in the East comes, you will get the very same support system you taught by example; so be a good example!

Officers are depended upon a great deal. It is easy to miss how much you matter, and it's totally normal at times to feel overwhelmed, critical of the leadership, or to wonder why you are doing it at all. It is not easy to serve. We often have other ideas of how we would do things, and we don't always feel appreciated or valued. Yet service is one of the ways in which Masonry makes us better men. When we help a leader even while disagreeing with him, we get to test our assumptions and ideas without taking on the consequences if he has made a mistake. Furthermore, it teaches us patience, exposes us to new perspectives, and gives us opportunities for charity-not in charity in the sense of "philanthropy", but benevolence (forgiveness, patience of shortcomings, encouragement)- that kind of charity all masons are charged to practice with one another, and which makes us worthy of emulation.

Master Masons are tasked with pure and simple participation. Only by coming to the place where "masonry" happens can you hope to be a "mason". A lodge is not the building, it is the brethren, so you are missed when you are not around. One who will wear a masonic ring and tell people he is a mason but won't join his fellows in the quarry is clearly fooling himself. Brotherhood is not something that can be faked, yet that is exactly what happens when we join a brotherhood and don't spend time with said brothers. Most importantly, you are needed every week to lend your voice, support the new members, and to continue your personal growth. You are mentor to the apprentices and fellows of the craft, and this is critical job. Now, if the lodge you joined is not your style; if it is lacking in brotherly love, in truth (education), and if it does not foster growth- then you have a duty to participate and help to build it into something better, for masons are, after all, builders!

Fellows and Apprentices, study and participate! Apply yourself in learning everything you can about the lessons and symbols of your degree, and the history of the fraternity. Come to every event and meeting you can. Get

to know every member you can and work right from the beginning to understand their unique experiences, perspectives, and values. Be sure to listen more than you speak so that you can soak in as much as possible just like the apprentices of old. You are the future masters and past masters of the lodge, use this time to learn about the system so that you can later teach it and improve upon it. Also, enjoy your time in the first two degrees, go slow and allow each stage to do its work in changing you for the better. Each has its own value to impart to you, rushing only cheapens the experience you get. Surely, we have three degrees for a reason!

May these suggestions help to strengthen us, and to demonstrate the vital role each of us has to play in the health of our lodge. After all, a lodge is only a mirror held before the faces of the members of which it is made. What do we see when faced with ourselves?





Who and Why are Honor Men?

This past June the Supreme Council met, and in their deliberations, selected what we call Honor Men. The term "Scottish Rite Honor Men" typically refers to men within the Scottish Rite of Freemasonry who have been recognized for exceptional service, leadership, or dedication to the fraternity. Within the Scottish Rite of Freemasonry, especially in the Southern Jurisdiction (USA), there are three primary honors that a 32° Scottish Rite Mason may receive:



#### Knight Commander of the Court of Honour (KCCH)

- Awarded to: 32° Masons who have provided outstanding service to the Scottish Rite.
- Selection Process: Nominated by peers and approved by the Supreme Council.
- Insignia: Red cap with a red band with the insignia of the Court of Honor
- Note: This is an honor, not a degree.

# Inspector General Honorary, 33°

- Awarded to: KCCH members who have shown extraordinary service to the Rite and Freemasonry in general.
- Insignia: White cap.
- Title: Once conferred, the recipient is referred to as a "33° Scottish Rite Mason" or "Inspector General Honorary."
- Note: This is considered a major honor and is by invitation only.

#### Grand Cross of the Court of Honour

- Awarded to: A very small number of 33° Masons for the most distinguished service.
- Insignia: White cap with a blue band with the insignia of the Grand

Cross.

• Note: Extremely rare and prestigious.

What It Means to Be an "Honor Man"

Being a Scottish Rite Honor Man means the recipient has gone above and beyond in:

- Service to Freemasonry
- Leadership in the Rite
- Charitable efforts
- Upholding the highest Masonic principles

These honors are not self-applied for they are earned through consistent, selfless service and recognition by one's peers.

More info can be found in our library about the history of these honors.
