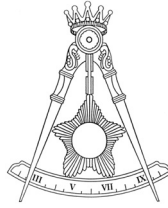
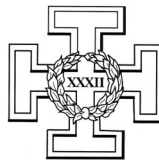

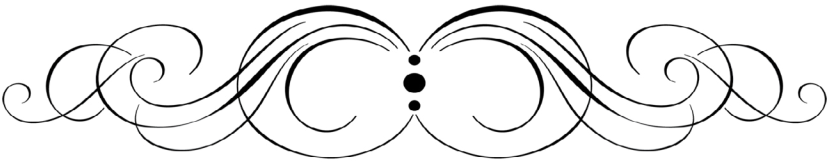

The P.R.'s Corner

On May 1, 2026, after our stated meeting, the brethren of the Valley of Pasadena along their guests, retired to the P. R.'s office to participate in the dedication of the time capsule which marked the end of the 100th anniversary celebration of the cathedral. Locked in the vault are accounts of various activities which made headlines globally, nationally and locally including the accounts of our celebration along with the program, script, pictures and memorabilia presented that night. During the time capsule dedication, the following letter from our brethren to the future membership of the Valley of Pasadena was submitted:



Greetings, Brethren!

The Valley of Pasadena was constituted in 1895 and chartered in 1899, the seventh such Valley in the state of California. Our first home, from 1895 to 1905, was a space that was rented in the Stanton Building on the corner of Ramond Avenue and Colorado Boulevard in the heart of a growing Pasadena.

Our next home, from 1905 to 1925, was located at 77 North Fair Oaks Avenue in a building purchased by the newly formed Pasadena Cathedral Association. It served us well until a more suitable, larger, and permanent location could be found.

The Cathedral Association next purchased a large plot of land in 1923, which was located at 150 North Madison Avenue in Pasadena. After a groundbreaking ceremony was performed, construction began in April of 1924. The cathedral was completed in February of 1925, and the first meeting was held that very same month.

A massive, much needed renovation of the entire building was conducted from 2020 through 2024, bringing the structure back into code and its original glory. In February of 2025, a grand gala celebration of the 100th anniversary of that first meeting in our brand-new home was held. This commemorative time capsule was sealed and dedicated in May of 2026. The Valley of Pasadena was truly here to stay.

And so, my brothers, this grand lady of Scottish Rite Freemasonry is now in your hands. Treat her with love and respect. Give her the care and attention she deserves. She is the home of the Valley of Pasadena, the best Valley in the Southern Jurisdiction!

A Sponsor's Responsibility

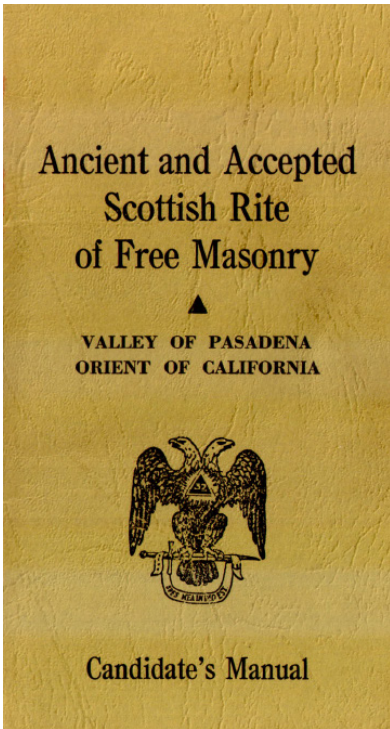
